RE: Russian Collusion and Equal Justice

Dear Senator Portman, Congressman Gonzalez and Congressman Joyce:

We write to you with regard to the matter of Russian interference in the 2016 presidential election and the individuals who orchestrated the accusation that President Trump colluded illegally with foreign operatives in order to win the election.

Now that the Justice Department has unequivocally cleared President Trump of charges of both collusion and obstruction, it is crucial that Republicans in Congress stand united and speak out loudly to demand equal justice from the band of unscrupulous left wing Democrats who continue to actively conspire to unseat the president and undo the will of the American electorate.

Specifically, we ask that you publicly call for an immediate and thorough investigation by Attorney General Barr into:

- 1) The possible abuse of power by the Justice Department, the FBI and various individuals during the agency's investigations into the 2016 Trump Campaign and afterward.
- 2) How and why the investigation into Hillary Clinton's use of a personal server was conducted and concluded by the Justice Department under the Obama administration.

We also ask that you actively and vocally support the efforts of Senator Graham in the Senate and Congressmen Jordan, Meadows, Collins and Nunes in the House, to both uncover the truth about the origins of the Russian Collusion Probe and to halt the kangaroo court inquiries into obstruction and other matters by House Democrats.

With regard to the latter accusations being made against the president, we would add that, after reading the entire Mueller Report, we find the actions of Democrat leadership to be nothing more than yet another smear campaign. Their actions are, in fact, as serious a threat to our Republic as the actions of any foreign government.
